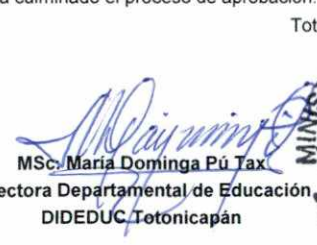
En el mes de marzo, aún existen 2 establecimientos que no se les pago, debido a que no han solventado todos sus trámites administrativos.
